**Shelterbelt Information - Fontmell Hill Estate**

The area of shelterbelt to be cleared to allow construction of the new dwelling is 0.09 hectares and has a standing volume of 2.25m<sup>3</sup>. The shelterbelt was planted in 1994 and comprises mainly Corsican Pine however, some broadleaved tree species (mainly ash & sycamore) have in filled through natural regeneration where the Corsican pine failed to establish. The Corsican pine has red band needle blight and thus growth has been severely stunted.
