Draft Minutes of a Parish Council meeting held on Monday 12th July 2010 at The School Hall, Fontmell Magna

Public Questions. The Chairman invited Mrs Way, Headmistress, to explain the reasons for the school development plans, she answered questions.

The following topics were also raised: The tranquillity of Collyers Brook, Replacement waste bin for play area (Afternote: fitting in hand); Publication of Schedules; Insurance of the play area; Dog mess being deposited in litter bins by bus stop.

10/07/01 New councillors sign acceptance of office. Cllrs Mrs J Foote, R Powell and C Taylor each signed the acceptance of office which was witnessed.

10/07/05 Matters arising from the minutes A response from NDDC regarding the wall in Parsonage Street was brought to the attention of members. Drains in West Street have been inspected by Highways – it was noted that they still smell.

10/07/11 Advertising sign outside the Surgery, West Street Following discussion, the Clerk was requested to contact the Abbey View Medical Centre to have the sign removed.

10/07/12 Quotation for repairs to the parish pump. A written quotation has been received from Mr Slatter. **It was proposed by Cllr King, seconded by Cllr A Taylor that the quotation be accepted and Mr Slatter be asked to proceed.**

10/07/13 Other parish matters

a. Highways. Members were briefed on the revised system for the use of Parish Maintenance Units. Any items for inclusion must be passed to the Clerk by 15 August. No date has been received for the A350 closure.

b. Rights of way. Cllr Foote reported that the restricted path from Pen Hill to Pipers Mill was very overgrown.

c. Parish Plan including a community shelter. Community Shelter. Work on the community shelter continues.

d. Village Hall. AGM 28 July.

10/07/14 DAPTC matters. Highlights from the latest DAPTC circular were brought to the attention of members.

10/07/15 Recent correspondence (not covered elsewhere). A complaint about anti-social behaviour had been circulated to members, it was noted that the council had no powers in the matters and that a response to that effect should be sent.

10/07/16 Councillor's update. It was agreed that Cllr Foote would be responsible for planning at Bedchester / Hartgrove, Cllr Taylor for highways, Cllr Powell to assist with Emergency Planning. Cllr Foote reported that the sign for the bridleway from Penn Hill to Vale Farm in Sutton Waldron parish had been removed.
